

This book introduces European legal research methods to Americans and American legal research methods to Europeans and thus makes it possible for them to speak the same language of the law. It is a paramount coursebook on legal research which breaks the oceanic divide. Furthermore, it is the first legal research guide to consider the internationalization and globalization in both the new law school curriculums and the changing practice of law.

Legal Research Methods in a Modern World: A Coursebook is a revised and expanded edition of Legal Research Methods in the U.S. and Europe, 2. edition. The title of this third edition has been changed to reflect the broader scope of the book due to the inclusion of chapters on China, Russia, England, and on researching foreign law generally. It is a coursebook intended for several alternative courses on legal research. As for American legal research, the book explains the impacts and effects of the major changes and developments that have occurred very recently, including the introduction of Bloomberg Law, WestlawNext and the revolutionary Law.gov movement.
